Minor(s) and in consideration of use of the facilities, any and all equipment and services of the Orange County Indoor Shooting Range (Range), do hereby enter into this Release and Hold Harmless Agreement (Agreement) on the _____ day of _____, 20____, and any and all future dates, and consent and agree that:

_____I represent that I have never been convicted of a felony in any of the 50 United States or its territories, nor have I been dishonorably discharged from any branch of the United States Military. California law prohibits any person convicted of a felony to be present in any environment where firearms are present. I further represent that I am LEGALLY allowed to POSSES a firearm.

_____ I represent that I am experienced and skilled in the proper handling, loading, use and discharge of all firearms and ammunition I intend to use at RANGE. I understand that the RANGE is specifically relying on the truth of my representations concerning my experience with firearms, in permitting me to make use of the RANGE. I also understand that if I am in any way unfamiliar with the proper handling, loading, use and/or discharge of firearms or ammunition which I intend to use at the RANGE, Range may provide me, at my expense, instruction in the proper handling, loading, use and discharge of such firearms and ammunition. In the event that I cause an injury to myself or another person, or their property, I AGREE TO INDEMNIFY AND HOLD HARMLESS ORANGE COUNTY INDOOR SHOOTING RANGE, ITS PARENT COMPANY, AGENTS AND EMPLOYEES FR OM ANY AND ALL CLAIM(S) FOR INJURIES, DAMAGES, ETC OR DAMAGES BROUGHT BY THAT INJURED PERSON AS A RESULT OF MY ACTS OR OMISSIONS and/or the Range's and/or employees acts or omissions WHETHER NEGLIGENT OR OTHERWISE.

In consideration of the acceptance of my application to use the RANGE, which use includes, but is not limited to, the use and discharge of firearms at the RANGE, the use and discharge of rental firearms provided by the RANGE and the services and training by employees of the RANGE, I ON BEHALF OF MYSELF, AGENTS, ASSIGNS, HEIRS, SURVIVORS, EXECUTORS, ADMINISTRATORS, etc. HEREBY AND FOREVER RELEASE AND DISCHARGE ORANGE COUNTY INDOOR SHOOTING RANGE, IT'S PARENT COMPANY, EMPLOYEES, AGENTS, OWNERS, CORP OFFICERS, ETC., AND ASSIGNS FROM ANY AND ALL LIABILITIES, CLAIMS, DEMANDS OR CAUSES OF ACTION THAT I MAY HEREAFTER HAVE FOR INJURIES, ILLNESSES, DEATH AND/OR DAMAGES ARISING OUT OF MY USE OF THE RANGE OR MY PRESENCE AT THE RANGE, INCLUDING BUT NOT LIMITED TO, LOSSES CAUSED BY (1) THE NEGLIGENCE OF ORANGE COUNTY INDOOR SHOOTING RANGE, AND/OR IT'S EMPLOYEES, AGENTS OR ASSIGNS, OR (2) RICOCHETS OF BULLETS OR BULLET FRAGMENTS, OR (3) THE ACTS OR OMISSIONS OF THIRD PARTIES, OR (4) HIDDEN, LATENT, OR OBVIOUS DEFECTS OF THE RANGE FACILITES, INCLUDING BUT NOT LIMITED TO, THE BULLET TRAPS AND THE ASSOCIATED COMPONENT PARTS OF THE RANGE.

_____ I understand and acknowledge that the RANGE is a location in which firearms discharge deadly ammunition. I further understand that the discharging of firearms and the use of ammunition have inherent dangers that no amount of care, instruction, or expertise can eliminate. I further understand that the RANGE is an indoor shooting facility which utilizes a series of component parts, including a bullet trap to decelerate discharged ammunition, however I understand that these component parts and bullet traps of the RANGE DO NOT, IN EVERY INSTANCE, CONTAIN BULLETS OR BULLET FRAGMENTS AND HAS BEEN KNOWN TO CAUSE RICOCHETS WHICH COULD CAUSE SERIOUS PERSONAL INJURY OR DEATH and I EXPRESSLY AND VOLUNTARILY ASSUME ALL RISKS OF PERSONAL INJURY OR DEATH SUSTAINED WHILE USING THE RANGE INCLUDING but not limited to (1) THE RISK OF NEGLIGENCE OF ORANGE COUNTY INDOOR SHOOTING RANGE, IT'S PARENT COMPANY, IT'S EMPLOYEES, AGENTS AND/OR ASSIGNS, (2) RICOCHETS OF BULLETS OR BULLET FRAGMENTS, OR (3) THE ACTS OR OMISSIONS OF THIRD PARTIES, OR (4) OBVIOUS, HIDDEN OR LATENT DEFECTS IN THE RANGE FACILITIES, INCLUDING BUT NOT LIMITED TO, THE BULLET TRAPS AND THE ASSOCIATED AND COMPONENT PARTS OF THE RANGE, I further agree that oral representations, statements, or inducement apart from the foregoing written Agreement have been made and that any modification of the Agreement will be effective only if it is in writing and signed by the party to be charged as well as a RANGE corporate officer.

_____ I acknowledge that I am in sufficient physical and mental condition to engage in sport shooting on this range. I further acknowledge that I am not under the influence of any alcohol or drug that may impair my physical or mental condition.

_____ I have made an independent evaluation of the risks associated with my use of the RANGE AND I UNDERSTAND THAT I MAY CONSULT WITH MY ATTORNEY CONCERNING THIS AGREEMENT and based thereon prior to use of the RANGE, I RE-AFFIRM MY ASSUMPTION OF ANY AND ALL RISKS INCLUDING BUT NOT LIMITED TO THE RISKS SET FORTH ABOVE and I hereby indemnify, without qualification or limitation, hold harmless any and all parties or companies associated with the Orange County Indoor Shooting Range. I understand I must carefully read and understand the RANGE RULES set forth in the documents entitled "RANGE RULES", and that my signature below signifies that I have read and understand these rules and agree to follow and abide by each rule. I understand that eye protection, in the form of safety glasses and hearing protection are mandatory and are available for my use, for a fee, while I am at the RANGE. THE PARTIES HERETO ACKNOWLEDGE HAVING READ AND UNDERSTOOD THIS AGREEMENT.

Range Rules

- 1. Do NOT, under ANY circumstance, cause harm to yourself or others.
- 2. Firearms brought into the building must be unloaded. If firearm is not in a case or container, the action or cylinder must be locked open.
- 3. All firearms and ammunition are subject to inspection and approval by range officers.
- 4. Rifles are allowed ONLY if they are pistol caliber.
- 5. Shotguns are allowed with slug ammunition ONLY.
- 6. No holstered firearms are allowed in or on the range at any time without prior permission (PC 832 exempt).
- 7. Range officers will remove anyone handling a firearm in an unsafe or inappropriate manner.
- 8. Range officers will remove anyone believed to be under the influence of drugs or alcohol.
- 9. Firearms may only be discharged in the booths at the firing line and must be pointed down range toward the backstop at all times.
- 10. Persons under the age of 18 must be accompanied by an adult at all times, both on and off the range.
- 11. Everyone must wear ear and eye protection while on the range. Do not remove for any reason.
- 12. No more than 2 shooters allowed on a lane without range officer approval.
- 13. No steel jacket or steel core ammunition.
- 14. No rifle caliber handguns allowed. No black powder allowed.
- 15. Load and unload firearms in your assigned lane at the forward table only.
- 16. No smoking, food or drinks are allowed in the building at any time for your safety.
- 17. Do not, under any circumstance, bring any loaded or jammed firearms off the range for any reason. If there is a problem, lay the firearm down in your booth, pointed down range and notify a range officer.
- 18. No rapid-fire is permitted. Allow at least one second between shots.
- 19. Do not exchange firearms with another lane. Switch shooters, not firearms.
- 20. On the CEASE FIRE command, unload your firearm, remove the magazine, open the action, lay firearm down and step back against the back table. Do not move back into the booth for any reason until the range officer calls ALL CLEAR.
- 21. When entering or leaving the range, wait for one door to close before opening the second door.
- 22. Rental guns must be used with range ammunition only.
- 23. Rental guns must be returned with the magazine out and action or cylinder open.
- 24. Destroyed target hangers will result in a \$5.00 charge per damage.
- 25. Destroyed target clips will result in a \$2.00 charge per clip.
- 26. No pregnant women are allowed on the range at any time for the baby's safety.
- 27. Any person with a medical disorder which might create a safety hazard must notify range officers prior to going out on the range.
- 28. Do NOT throw any ammunition or brass into the trash containers.
- 29. Clean up after yourself. Push all casings forward of the firing line.
- 30. Do NOT go forward of the firing line or pass in front of booths at any time for any reason.

I have read and FULLY understand all of the above rules and I agree to abide by them every time I am at the Orange County Indoor Shooting Range.
